I will be responsible for all tuition and costume payments that are accrued at the Utah Dance Center. I will be responsible for tuition payments until I notify the Utah Dance Center that I will no longer be attending the class in written form.

I understand that no refunds are available and that tuition is paid on a quarterly basis based on an annual rate rather than per lesson. There are no refunds for missed classes. I agree that the Utah Dance Center may use photographs of me with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 and all viruses.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

UTAH DANCE CENTER INC. of Sandy UT has put in place preventative measures to reduce the spread of COVID-19; however, the Utah Dance Center cannot guarantee that you or your child(ren) will not become infected with COVID-19 or other viruses.
